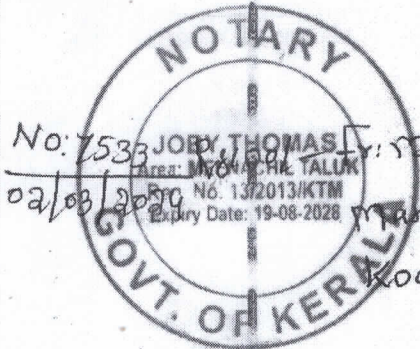
1. I am the secretary of the Board of Trustees of Marygiri Educational and Charitable Trust, a registered Trust with Reg. No. IV 389/1996.

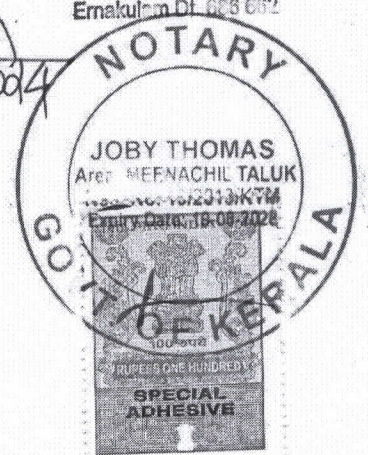
